Report of the Executive Director

At Westmoor, the cable company continues to work on cleaning up the wiring. EHA recently completed an underground survey for utilities. The cable company will now bury the overhead temporary wires that were installed several years ago. In addition, the cable company will also clean up the wiring in each of the apartments.

At Foti and Morse, EHA will implement its first rent increase since 2009. The \$8,000 in additional annual rent will assist in the planned capital improvements to the properties.

The next tenant meeting is scheduled for Tuesday, October 25th. The tenant meetings have been very useful in getting a good understanding of tenant needs. Tenant meetings will be held every other month.

EHA would like to congratulate its receptionist Jere Wiggins on accepting a new position at the Newark Housing Authority. We wish her lots of success and happiness. She was a terrific employee and will be an asset to her new employer. EHA has selected her replacement, Mrs. Sara Quinones, and Ms. Wiggins will train her replacement prior to moving on.

EHA started a new coloring program for the residents at Tibbs. EHA covers the cost of the supplies (e.g. pencils, coloring books, etc.). The program has been very successful to date with at least 10 residents participating every week.
