Minutes

A motion was made by Commissioner Correa and seconded by Commissioner Gurfein to approve the minutes of the November 27, 2017 Board Meeting. The motion carried with all in favor.

Report of the Executive Director

On Saturday, September 9th, we had our first snow event of the season. Three EHA staff members began clean up at approximately 6pm and worked until midnight. EHA staff returned Sunday morning to take care of any icing. The three staff members performed admirably. A pallet-and-a-half of ice melt was utilized for this snow event. Two snow blowers were taken to the mechanic Monday morning to be serviced. Large objects (i.e. a phonebook and a walk off mat) were sucked into the machines. Moving forward, as a precautionary measure, staff will walk the sites immediately prior to a snow event to ensure no objects are left on the ground that can clog the snow blowers. In addition, a notice will go out to Westmoor Garden tenants informing them to bring in their walk off mats prior to a snow event. Finally, as recommended by our insurance company, all snow removal activities were logged and filed.

We currently do not have any vacancies.

A motion was made by Chairman Aspinwall and seconded by Commissioner Jones to approve the bills and claims for the month of December. The motion carried with all in favor.

The Board of Commissioners voted unanimously to name Raymond Aspinwall as Chairman and Carla Jones as Vice-Chairman.
