<u>Minutes</u>

A motion was made by Vice Chairwoman Cobb and seconded by Commissioner Correa to approve the minutes of the May 23, 2022 Board Meeting. The motion carried with all in favor.

Executive Director's Report

Vincent K. Tibbs Senior Building

- EHA is continuing to work with the architect/engineer on the RFP specifications for the new boilers, electrical panel, fire pump, generator, etc. EHA's insurance company will need to review the specifications prior to advertising the RFPs. The insurance provider will cover the cost of replacing the equipment, but it will not cover improvements, i.e. raising the equipment above the flood level. These improvements will be covered by FEMA. Unfortunately, the insurance review will add time to the project. EHA hopes to advertise the RFPs in early August so that the awarding of the projects can take place at the September Board meeting.
- EHA was party to a class action lawsuit against HUD. A few years ago, HUD
 recaptured reserves of public housing authorities throughout the country. A
 lawsuit was successful, and EHA received a check for \$80,369 which was
 deposited into the Tibbs operating account.

- EHA will be submitting all the hotel receipts to FEMA for reimbursement in July.
 EHA anticipates reimbursement will be received in November.
- EHA is continuing to work with our insurance company to ensure EHA remains financially sound. The insurance company will be covering EHA's rental losses which are approximately \$100,000 a month. The insurance company has provided EHA an initial advance of \$1.75M so that EHA can continue to operate and complete our restoration work.
